



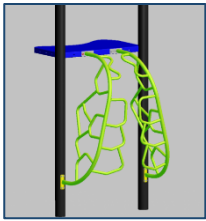

PRODUCT RECALLS



PRODUCT/FIRM: Metal Playground Climbers by BCI Burke

DESCRIPTION: This recall involves the Burke Merge Metal Climbers. These climbers are used on play equipment as an attachment that allows children to climb up and access the play structure.

The metal climbers were sold in many color combinations with small geometric shaped openings with a platform and two welded handgrips at the top. “Burke” is printed on identification labels that are placed on the exterior of the entire play structure.

REMEDY: Consumers should immediately remove these climbers from use and contact the firm for a free repair kit. Consumers may contact BCI Burke by phone at 800-356-2070 from 8:00 AM to 4:00 PM, Monday through Friday; or online at www.bciburke.com by clicking on “Climber Recall.”



PRODUCT/FIRM: TubeEZ Baby Bath by Abond Group

DESCRIPTION: This recall involves the TubeEZ Baby Bath Support Seats. The baby bath support is a rigid

plastic seat attached to a foam mat for use in the bathtub. The foam mat is either blue (model code B9150BL) or gray (model code B9150GY) and features multiple suction cups on the underside. The affected seats have the date codes 1251-0916-enj-nacn or 1434-0617-enj-nacn printed on the underside of the mat.

REMEDY: Consumers should immediately stop using the recalled bath support seats and contact Abond Group for a full refund. Consumers may contact Abond Group by phone at 800-886-7947 from 8:00 AM to 4:00 PM, Monday through

PRODUCT/FIRM: Eddie Bauer Infant Carriers by Gold Inc.

DESCRIPTION: This recall involves Gold Inc.’s Eddie Bauer fabric infant carriers sold exclusively at Target. They are worn

by the parent or caregiver with the baby strapped into the front. The recalled carriers are black with “Eddie Bauer” and “First Adventure” printed in gray lettering on the front, outside of the carrier.

REMEDY: Consumers should immediately stop using the recalled carriers and contact Gold Inc. to verify that the product is subject to this recall. Once the product is verified, consumers will receive replacement products of comparable value or a full refund. Consumers who purchased this recalled product must cut off and return both straps and tag with their name, address, and phone number to receive selected replacement products (free of charge) or a full refund. PRODUCT/FIRM: Infant Rattles by iPlay

DESCRIPTION: This recall involves the Green Sprouts brand flower rattle made from wood. The recalled multi-colored rattles are made from natural wood and measure 2.5 inches long by 2.5 inches wide by 4 inches high. Attached to the circular handle are three round wooden

balls shaped like flowers, including one that contains a silver metal bell; all attached with an elastic cord. “Green Sprouts,”

“Made in Taiwan,” and a date code number (14714 or 21815) are printed on the circular rattle handle.

REMEDY: Consumers should immediately take the recalled rattles away from children, stop using them, and contact iPlay for instructions on how to receive a \$50 coupon code to redeem towards the purchase of new products and shipping costs. PRODUCT/FIRM: Electric Skateboard by Yvolve Sports



DESCRIPTION: This recall involves the Neon Nitro 8 – a self-balancing, single-wheeled, battery-powered, electric skateboard from Yvolve Sports under the Neon brand. The product is powered by the user placing one foot on the rear and front decks, gaining balance, and then shifting their

weight backwards or forwards to control the speed. “Neon” is printed on the skateboard.

REMEDY: Consumers should stop using the skateboards immediately and contact Yvolve Sports to receive a new permanent warning label and updated instructions on how to properly inflate the tire. New instructions can also be obtained online at www.neonlygths.com. PRODUCT/FIRM: Slap Bracelets by Fantasia Accessories

DESCRIPTION: This recall involves children’s furry critter plush slap bracelets in panda, unicorn, and heart designs sold exclusively at Target. The recalled bracelets are made of a metal

band covered with a protective fabric. Only slap on bracelets are included in this recall.

REMEDY: Consumers should immediately stop using the recalled bracelets, take them away from young children, and contact Fantasia Accessories to receive a free replacement product. PRODUCT/FIRM: Children’s Toy Instrument Sets by Creative Sto

DESCRIPTION: This recall involves INNOCHEER children’s musical instruments sets sold exclusively on Amazon.com. The 18-piece

instrument sets have one xylophone, two mallets, two

maracas, one jingle stick, one sleigh bell, four shaker eggs, two finger castanets, one rainbow bell stick, one mini tambourine, and one triangle with striker. The instrument sets come inside clear plastic bags that measure about 8.9 inches by 8.9 inches by 3.2 inches and have a green trim, a yellow zipper, and handles. “INNOCHEER” is printed in green on the front of the bags. **REMEDY:** Consumers should immediately stop using the recalled instrument sets and carrying cases, take them away from children, and contact Creative Sto for a full refund – including the cost of shipping the product back to Creative Sto. PRODUCT/FIRM: Baby Carriers by LÍLLÉbaby

DESCRIPTION: This recall involves LÍLLÉbaby Active series baby carriers. These carriers can be worn by the caregiver with the baby strapped into the front or back position. The recalled carriers are the Active Series-Pro 6 in 1 in

Space Dye Cobalt and Space Dye Grey and the Active All Seasons in Slate. Each carrier has a yellow colored tag on the front neck support, outside of the carrier and on the back, chest clip pad, both of which have “LÍLLÉ” printed in black lettering and “baby” printed in white lettering on the label.

REMEDY: Consumers should immediately stop using the recalled carriers and contact LÍLLÉbaby to receive a free replacement baby carrier and a full refund. PRODUCT/FIRM: Girl’s Clothing Sets by H.I.S.

DESCRIPTION: This recall involves Self-Esteem brand girl’s clothing sets with a gold leaf pendant necklace. The recalled clothing sets consists of three items: a short-sleeve teal top with cut-out shoulders, a navy blue leggings pant with a

teal floral print, and a pendant necklace with an orange and teal center. The recalled clothing sets have style number PO#71160/LOT9 and a date of production of 10/2017 printed on a white label on the inside of the garment. The recalled clothing sets were sold in girl’s sizes 4x-12x.

REMEDY: Consumers should immediately stop using the necklace from the recalled clothing sets, take it away from children, and return it to the place of purchase for a full refund. PRODUCT/FIRM: Children's Water Bottles by Mountain Warehouse

DESCRIPTION: This recall involves a plastic 350ml children's water bottle. The water bottles come with a screw-on solid color top with a pop up straw and handle. A barcode is printed on the price sticker located at the bottom of it. The water bottles were sold in

multiple colors and prints including: tractors, hedgehogs, sharks, fish, and horses.

REMEDY: Consumers should immediately stop using the water bottles, take them away from young children, and contact Mountain Warehouse for a full refund. PRODUCT/FIRM: Children's Hooded Jackets by Meijer

DESCRIPTION: This recall involves Falls Creek Kids branded children's zip-up hoodies sold in five color styles in sizes 12M, 18M, 24M, 2T, 3T, 4T, and 5T. "Falls

Creek Kids" and "Made in China" are printed on the inner collar. The tracking number is printed on a sewn-in label on the inner side seam.

REMEDY: Consumers should immediately take the recalled hoodies away from children, stop using them, and return them to any Meijer store for a full refund. Consumers may contact Meijer by phone at 800-927-8699 anytime or online at www.Meijer.com by clicking on "Product Recalls."

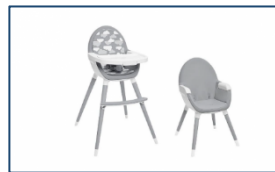


PRODUCT/FIRM: Nightlights by HoMedics

DESCRIPTION: This recall involves the HoMedics MyBaby Comfort Creatures Giraffe Portable & Bedside Nightlight, model MYB-N100GIR. The affected nightlights have the date code GP230118 or GP290318 (located on the underside of the product). It can be powered by an AC adaptor or two

AA batteries. It is yellow with brown spots and white underbelly. The nightlight is about 3 inches long, 5 inches wide, 7 inches high, and weighs less than 1 pound.

REMEDY: Consumers should immediately stop using the recalled nightlights and contact HoMedics for a full refund. Consumers may contact HoMedics by phone at 800-466-3342 from 7:30 AM to 6:00 PM, Monday through Friday; or online at www.homedics.com by clicking on "Product Recall."



PRODUCT/FIRM: Convertible High Chairs by Skip Hop

DESCRIPTION: This recall involves Skip Hop's Tuo convertible high chairs with charcoal gray or silver/white with clouds fabric.

They have a reversible seat pad, removable tray, 5-point harness, beechwood footrest, and legs. The high chairs can be converted into a toddler chair. One of the following style numbers and corresponding date code can be found on the back of the chair: Style Number 304200 (charcoal gray), Date Codes HH5/2017, HH6/2017, HH7/2017, HH8/2017, HH9/2017, HH092717, HH030518, HH05182018, or HH05312018; Style Number 304201 (silver/white with clouds), Date Codes HH092917 and HH010518.

REMEDY: Consumers should immediately stop using the recalled high chairs and contact Skip Hop for a full refund or an e-gift card of equal value. 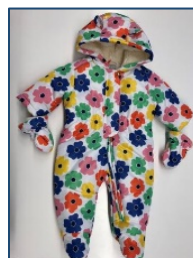


PRODUCT/FIRM: Children's Books by Manhattan Toy

DESCRIPTION: This recall involves "Find the Bear" soft fabric books with a variety of fabric flaps sewn or attached to the pages. The front cover has blue and purple horizontal stripes and a panda bear's face sewn

on. The Manhattan Toy logo is printed on a sewn-in label on the side of the book. Lot code "208150 AJ" is printed on another sewn-in label.

REMEDY: Consumers should immediately take the recalled books away from children, stop using them, and return them to the place of purchase or contact Manhattan Toy for a full refund. Consumers may contact Manhattan Toy by phone at 800-541-1345 from 8:00 AM to 5:00 PM, Monday through Thursday and from 8:00 AM to 12:00 PM on Friday; or online at www.manhattantoy.com by clicking on "Recalls."



PRODUCT/FIRM: Infant Snowsuits by The Children's Place

DESCRIPTION: This recall involves girls' infant snowsuits sold in infant sizes 0 to 18 months. The recalled snowsuits were sold in two styles and three colors/patterns. The style number is printed on a label sewn in to the side seam. The snowsuits are 100% polyester

and the trim is 95% polyester and 5% spandex. They have matching print hoods with small ears, detachable mittens, and a zipper down the front of the suit covered with a fabric snap flap at the chest.

REMEDY: Consumers should immediately take the recalled snowsuits away from children, stop using them, and return them to any The Children’s Place store for a full refund. Online customers will receive return instructions by email from The Children’s Place on obtaining a full refund. PRODUCT/FIRM: Children’s Robes by The Company Store

DESCRIPTION: This recall involves The Company Store children’s 100% cotton terry robes. They were sold in sizes XS, S, M, L, and XL in the following colors: blue, green, gray, orange, pink, purple, red, and white. The long-sleeved, hooded robes have two front pockets and two

side-seam belt loops with a matching belt. “The Company Store,” “RN#120962,” and a tracking number beginning with either “CS3981DR,” “CS0981DR,” or “28738” are printed on a sewn-in neck label.

REMEDY: Consumers should immediately take the recalled robes away from children, stop using them, and contact The Company Store for a full refund of the purchase price.
